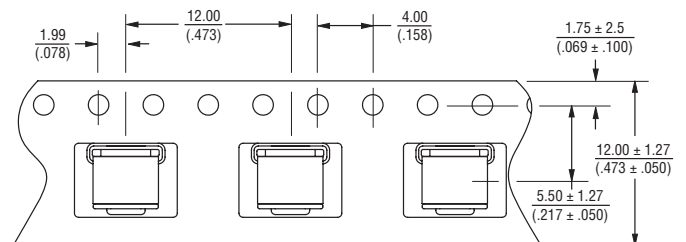
Reel is 13 inches in diameter and 11/16 inch wide.
