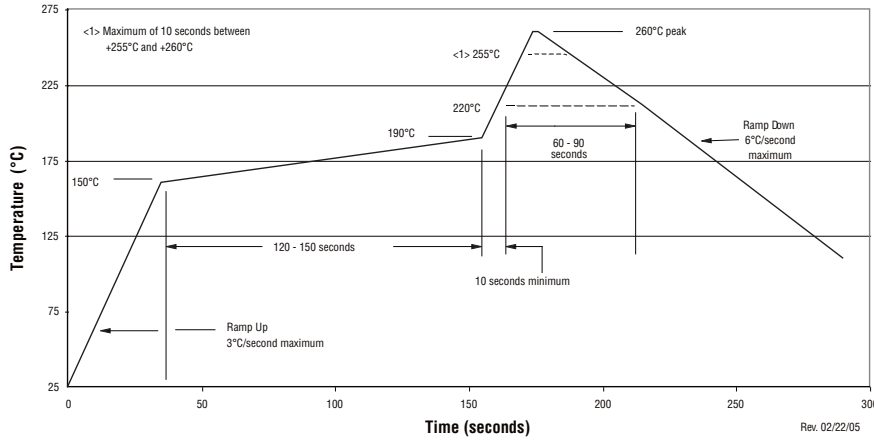


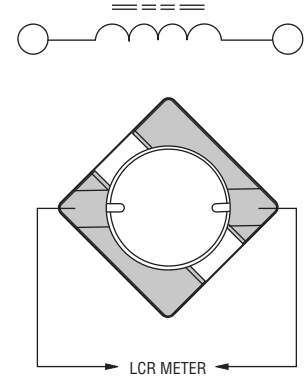

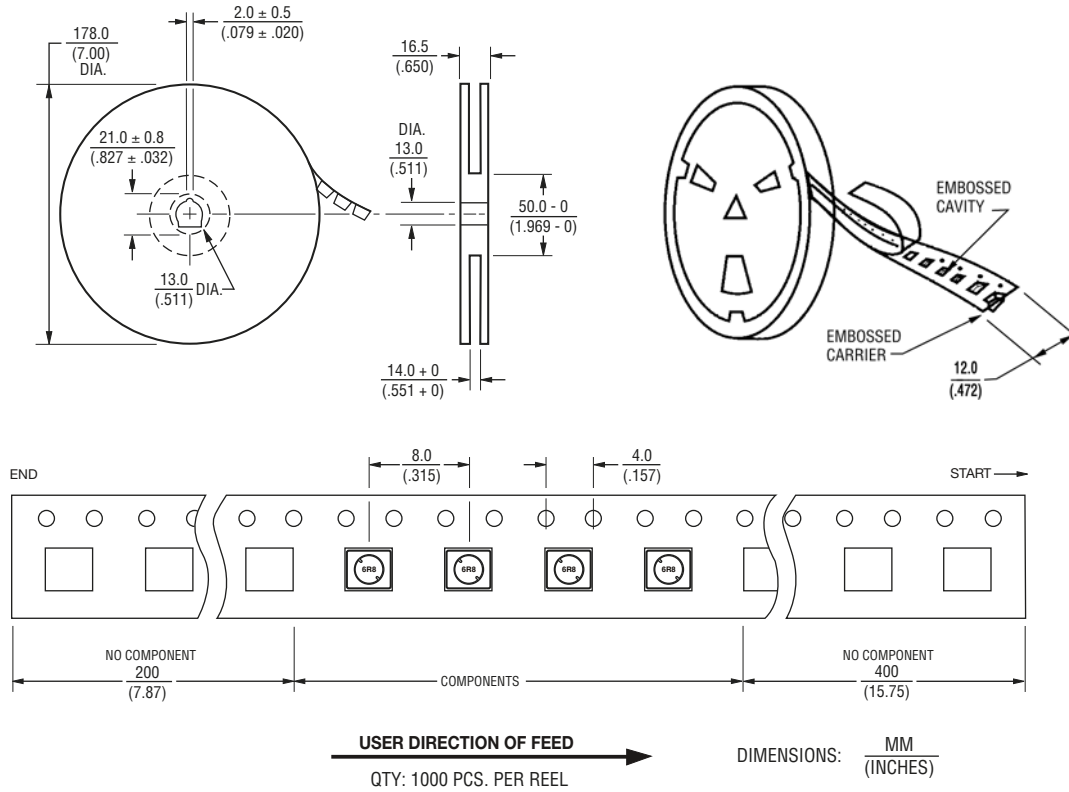
Soldering Profile
