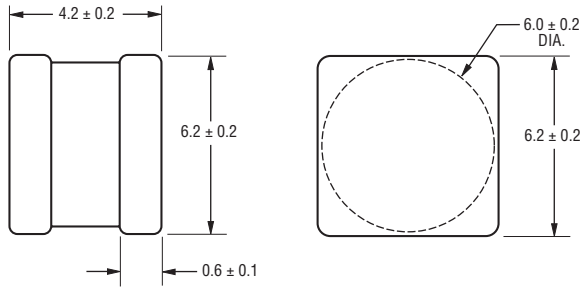

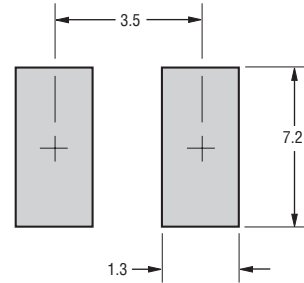


## Product Dimensions



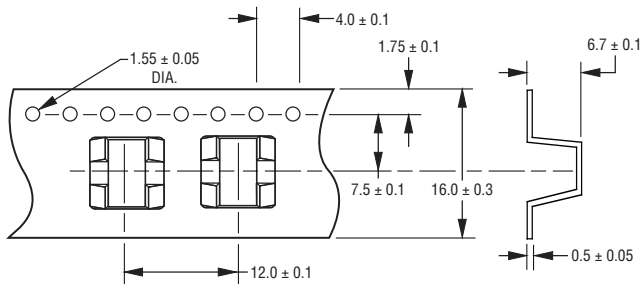
