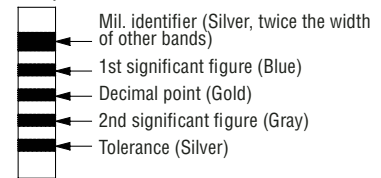

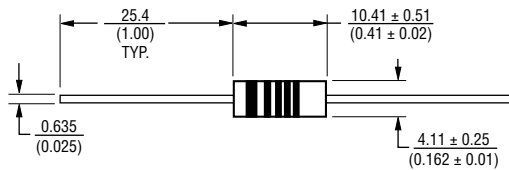

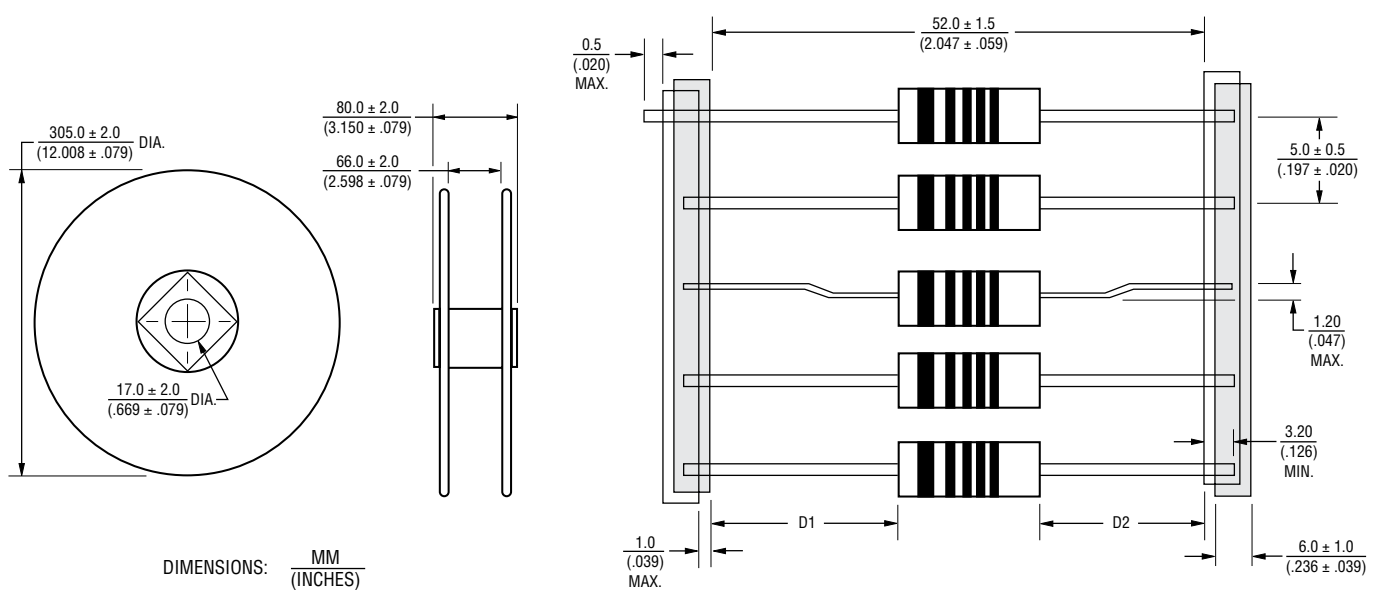


## Product Dimensions
