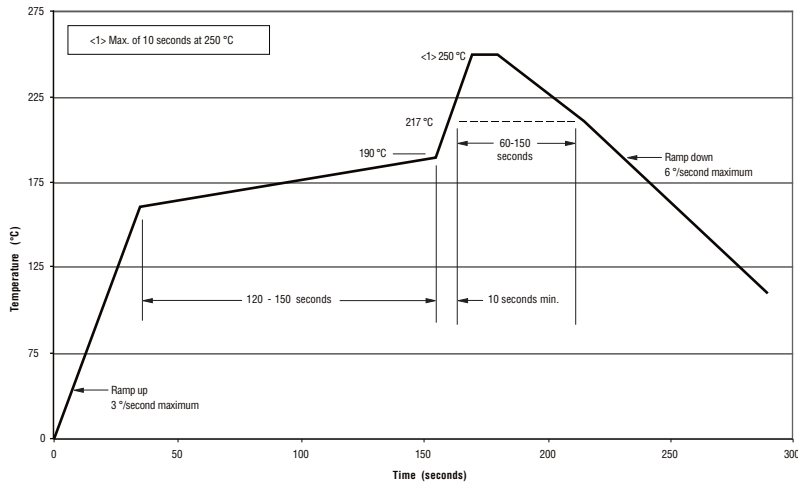


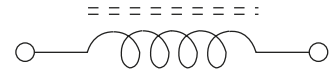

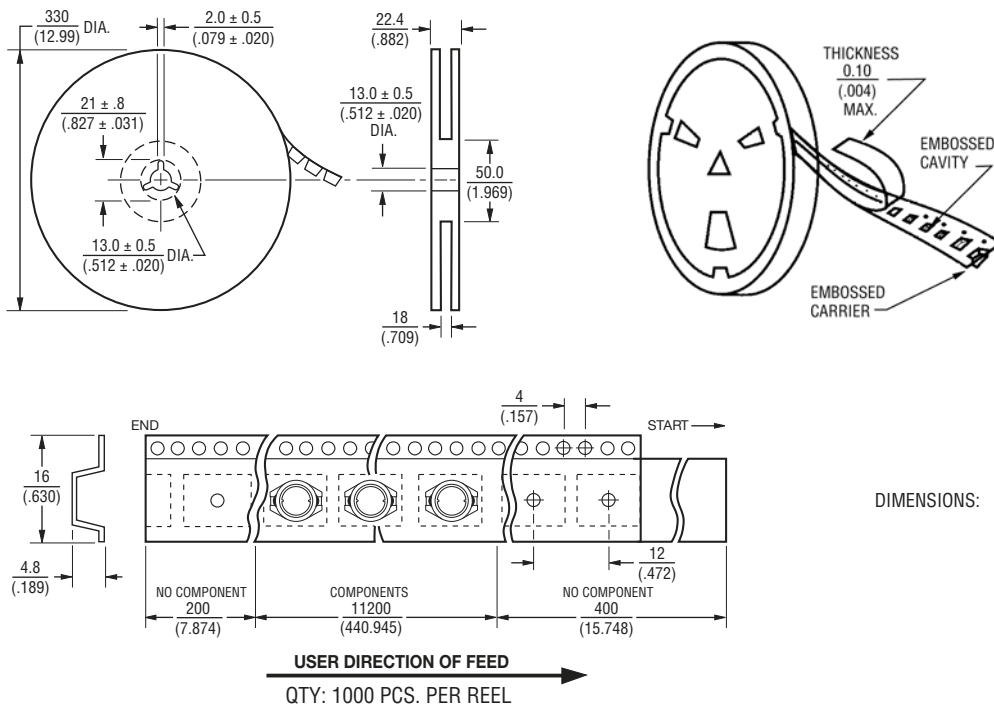
Soldering Profile
