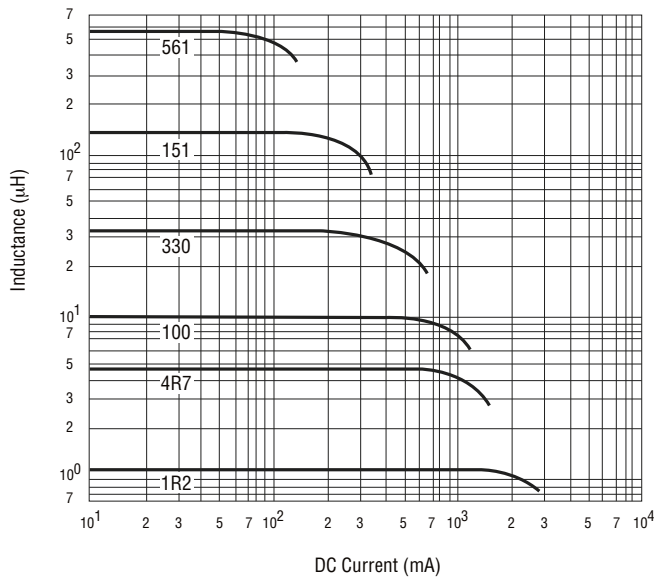


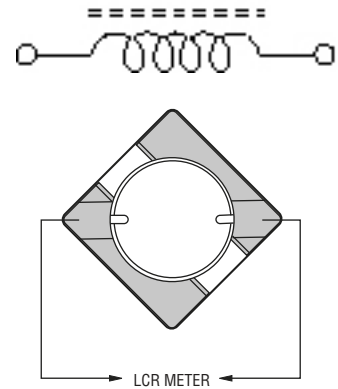

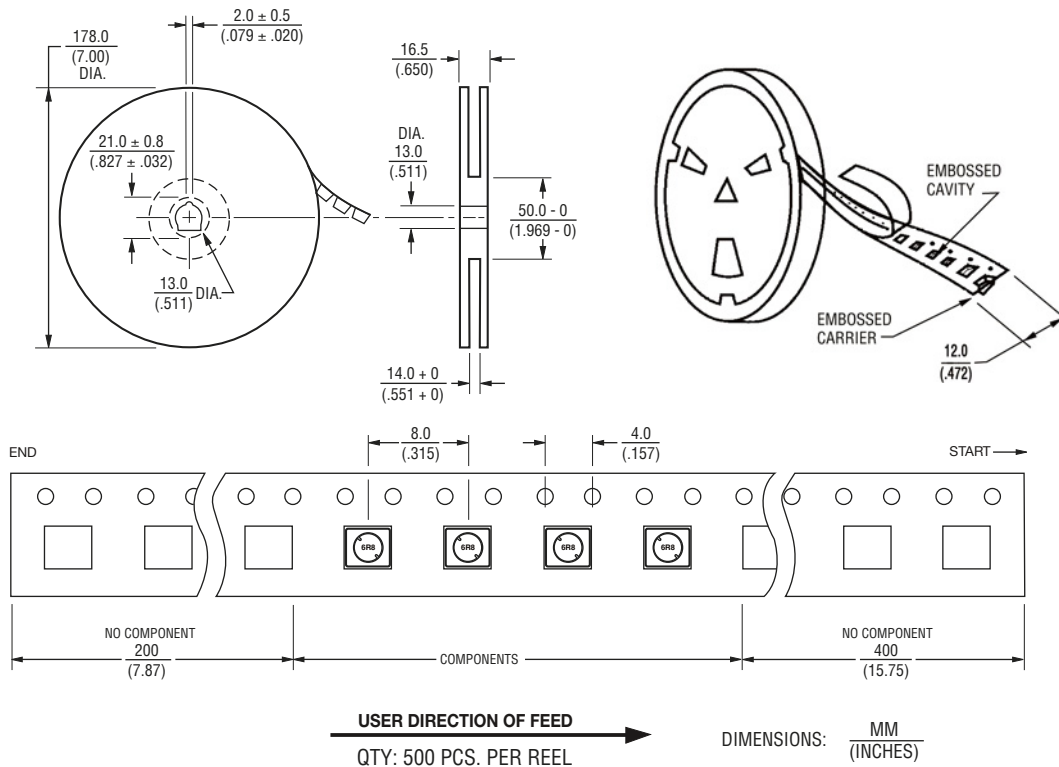
Inductance vs. Current
